All patients presenting to the obstetrical triage area are triaged and prioritized according to the OTAS tool.

Healthcare facilities providing inpatient obstetrical care should limit visitors to pregnant women who have known or suspected COVID-19 infections. Visitors should be limited to those essential for the pregnant woman's well-being and care (emotional support persons).
